Reunion Central

The Red Lion Hanalei Hotel in Mission Valley will be the **55th SRWA HQ** from **9-13 March (Wed-Sun) 2005**. The hotel has plenty of amenities – two dining rooms, a bar, pool, spa, fitness room, meeting rooms and a banquet room. The venue is conveniently located in Mission Valley, the heart of San Diego, just east of the Interstate 5 and I 8 interchange at 2270 Hotel Circle North.



Room rate for single or double is \$99. That rate is good for **three days** either side of the reunion booking (6-16 March).

To make your hotel reservations, the number to call is 1-800-882-0858. It goes directly to the hotel's reservation desk. Or you can book on-line at: www.hanaleihotel.com, click on 'Reservations', then click on 'Groups'. The password is **55RECON**. You can get all the information on the hotel, as well.

Transportation to/from airport is not provided by the hotel, but cab fare is less than \$20. Cloud Nine Shuttle service can be arranged ahead of time by calling 1-800-974-8885.

The hotel is on the famous and convenient trolley line which connects to Old Town, Downtown, Tijuana, and several other places and sights of interest in the San Diego area. Adjacent to the hotel is the scenic Riverwalk, and the Embarcadero on San Diego Bay is just ten minutes south.

San Diego is renowned for its great weather all year round, scenic beauty, a great waterfront and marinas, all sorts of history, attractions, entertaining tours, recreation, and outstanding shopping and restaurants.

Reunion Activities

Bill and Carol Lewis have worked on this gathering since they returned from the one in Dayton last year. They have a schedule planned for

the attendees to include the always popular hospitality room (with many and convenient hours), an obligatory golf outing, tours, a dining cruise, a membership meeting and the grand banquet. NOTES: Included with this newsletter are: A description of the tours offered and a daily schedule of events. Please note that there are two tours offered each day and the times are the same or overlap (the dinner cruise being the exception), so just pick and pay for one tour a day.

MEMBERSHIP REPORT

As of 1 October 2004, the Association had 1034 members in good standing, 159 of which are Honorary Life Members (HLM), 13 are Life Members (LM) and 39 associated members. This is an decrease of 59 members since 1 May 2004. (*Lapsed and TAPS.*)

The Association has members in **49 states** (*still no Alaska rep*), DC, Guam, Puerto Rico and APOs in Europe.

The good news is that the number of **active duty members** continues to rise as interest has picked up due to the Association's exposure in the Offutt area, and as members continue to recruit.

The most frequently asked question of the membership chairman is "when do my dues expire?" Explanation: **On the top line of your address label for this newsletter, or in the greetings line of e-newsletter, will be a year number or letters.**

Those indicators are herein defined: 2006 means your **dues expire at the end of that year**, and you are a member in good standing. Likewise, any other year shown indicates when your **dues expire, or have already expired**. In the latter case, **its time to reup, now**.

LM indicates you are a life member. *Dues not required* .

HLM denotes Honorary Life Member (widows and other selected persons who have made significant contributions to the status of the Association). *Dues not required*.

Assoc denotes an affiliated organization, or position in same; or active duty position: such as **55 Wing CC** and other **55th Wing** senior staff members. *Dues not required*.

55th WING HALL OF FAME

In 2003 the [55thSRW Assn](#) assumed the administrative lead for the selection process of the [55th Wing Hall of Fame](#).

Nominees for induction are being solicited for 2004 to be announced at the Wing Birthday Ball in February 2005.

That process has been an evolving one for a number of years, and this year an Association presidential appointed committee continued the revision and refining for the selection criteria and process.

Following is the latest directive for the program.



HALL OF FAME RECOGNITION PROGRAM

Administered by

[55th Strategic Reconnaissance Wing Association](#)

This document establishes the [55th Wing Hall of Fame \(HoF\)](#) recognition program as administered by the [55th Strategic Reconnaissance Wing Association \(55thSRWA\)](#). It prescribes the procedures for nomination and selection of members to the HoF.

Objective: To recognize those former members of the [Fightin' Fifty-Fifth](#) whose mission accomplishments, contributions, and/or sacrifices stand out while performing or providing direct support to the mission of the [Fightin' Fifty-Fifth](#).

General: On behalf of the [55th Wing](#), the HoF program recognizes former members of [Fightin' Fifty-Fifth](#) for significant mission accomplishments, contributions, and/or sacrifices in support of the mission of the [Fightin' Fifty-Fifth](#). HoF induction will occur on an annual basis, with nominations accepted from July through October of each year. A maximum of two (2) awards (a crew will be considered as one

award) may be given in one year. Consideration of nominees does not mandate selection to the HoF. In coordination with the [55th Wing](#), the newest inductees selected for the HoF may be announced during the annual [55th Wing Birthday Ball](#) or other venue as determined by the [55thSRWA](#) and in coordination with the [55th Wing](#).

The final selection will be the end result of two processes:

1. The HoF Screening Committee will receive and review all nomination packages and select those to be considered by the Selection Committee. Nominees for the HoF recognition will be former military members who have served as members of any of the following units: [55th Pursuit Group](#), [55th Fighter Group](#), [55th Strategic Reconnaissance Wing](#) and/or [55th Wing](#). These units will hereinafter be referred to as [Fightin' Fifty-Fifth](#). The HoF Screening Committee will be chaired by an Omaha-based member of the Board and be comprised of at least four Association members in good standing, one of which will be the [55 Wing Vice Commander](#) or his designated representative.
2. The Selection Committee will consider all nomination packages forwarded by the Screening Committee and make the final selection recommendations to the [55th SRWA Board of Directors](#) for their approval. The Selection Committee will be comprised of Chairman of the Awards Committee, Chairman of Screening Committee and not less than three or more than five Omaha-based Association members in good standing, one of which will be the [55 Wing Vice Commander](#) or his designated representative.

Eligibility

1. Must have been assigned to the [Fightin' Fifty-Fifth](#).
2. Mission accomplishments, contributions, and/or sacrifices must have been accomplished while assigned to and performing the mission of the [Fightin' Fifty-Fifth](#); **or** having been assigned to the [Fightin' Fifty-Fifth](#), the mission accomplishments, contributions, and/or sacrifices must have had a direct, significant and sustained impact on the accomplishment of the [Fightin' Fifty-Fifth's](#) mission.
3. Nominee cannot be on active duty.

6. Nominations **must** be signed by nominator and one additional individual who was either witness to the acts, unyielding service, etc., or someone who can attest to the validity of the nomination. In the absence of an additional signature, the nominator must provide supporting documentation wherever possible to ensure the HoF selection committee can be convinced of the authenticity of the facts forwarded in the nomination.

RESPONSIBILITIES

The 55 SRW Assn administers this program.

Nomination schedule:

First week in June – Process review

First week in July – Call for nominations

NLT 15 October – Receives and screens all nomination packages

NLT 1 November – Forwards nominee packages to Selection Committee.

The Chairman and Members of the Screening Committee

Screens all nominations for eligibility.

The Selection Committee - Makes final selection of HoF Inductees.

The 55th SRWA President:

- a. Prepares “Call for Nominations” memo for inclusion in the **55thSRWA** newsletter and website.
- b. After the Selection Committee has finalized the selection of any new inductees, the President will forward this information to the Board of Directors for concurrence.
- c. Informs the **55 Wing** Commander of the new inductees.
- d. In consonance with **55th Wing** Protocol and Wing Birthday Ball Project Officer, coordinates presentation at the annual **55th Wing** Birthday Ball, or other event or venue as coordinated between the **55th Wing** and the **55th SRWA**.



THE 55TH SRW ASSOCIATION AWARD FOR EXCELLENCE

The 55th SRW Association Annual Award for Excellence is presented to that individual, crew, group, or organization that best exemplifies the basic tenants of the **55th SRW Association**.

The award winners are announced at the annual **55th Wing** Birthday Ball and at **55thSRWA** reunions. Their names are inscribed on the base of the trophy and they receive a representative plaque.

The previous award recipients are **LtCol Ricky McMahon**, 338th Combat Training Squadron commander, 2000; and **MSgt Steven and MSgt Lisa Hagggett**, **55th Wing** Command Section, for 2001; **LtCol Kurt Kramer**, 38th RS commander, for 2002; and **Col (select) Glen Gulleckson**, 343rdRS commander, in 2003.

The unveiling of the imposing trophy always gets an appreciative response from the crowd at the Ball.



SILVER STARS AWARDED OLMSTEAD AND MCKONE

A **55th SRW** RB-47H was shot down by a Soviet MiG pilot on 1 July 1960 over the Barents Sea. Four of the crewmen perished in that unprovoked attack: AC/pilot **Willard Palm**, EWOs **Dean Phillips**, **Oscar Goforth** and **Eugene Posa**. The copilot and navigator ejected successfully and survived over six hours in the frigid ocean until they were ‘rescued’ by Russian fishermen.

Bruce Olmstead, the CP, and **John McKone**, navigator, subsequently spent seven months in the infamous Lubyanka Prison in Moscow. They were released in January 1961 as a gesture to newly elected President John F. Kennedy.

Forty-three years later, the two retired colonels were awarded Silver Stars on 13 September at the opening ceremony of this year’s Air Force Association convention in Washington, DC. Secretary of the AF **Dr. James Roche**, and **General John Jumper**, Chief of Staff of the USAF, officiated.

Following is an edited release from USAF Public Affairs: “Secretary Roche and General Jumper specifically recognized both men, presenting the Silver Stars to retired Cols John McKone and Freeman B. Olmstead.

The officers distinguished themselves during operations 1 July, 1960 to 24 January, 1961. During that time the two **55th Strategic Reconnaissance Wing** crewmen were held captive in solitary confinement in a Moscow prison after a Soviet fighter aircraft had shot down their RB-47 aircraft over international waters.

For 208 days the two men were continuously questioned and harassed by numerous Soviet secret police interrogation teams.

Although gravely weakened physically by the lack of food, denial of sleep and the mental rigors of constant interrogations, the two steadfastly refused to give sensitive defense information, or to be exploited for propaganda purposes. They resisted all Soviet efforts to obtain the confessions the captors sought as part of a pretrial investigation.

After enduring seven months of unrelenting hardship, the officers were finally released to the United States under the condition that the situation would not be used as a public demonstration of Soviet defeat. A showcase trial in the Soviet Union was never held.”

Several **55th SRW** veterans were present, among them: Bill Ernst, **Larry Mitchell**, Jim Thomas, Mike Cook, **Bill Betz**, **Tom Shepherd**, and **Tommy Harrison**.

Ms. Stacey Knott from the 55th Public Affairs Office covered the event for the **55th Wing**. Her article on the presentation was in the 17 September issue of the *Air Pulse*, the Offutt base paper.

55TH WIDOWS VISIT RUSSIA

The widows of Dean Phillips and Oscar Goforth could not possibly have conceived of the events that would transpire over time to have them travel to Russia 44 years later.

Pat Phillips and **Maria Goforth McAtee** attended a POW/MIA conference in Washington, DC, a few years ago, and while there they met **Russian Navy Rear Admiral (Ret) Boris Gavrilovich Novvy**. He is an expert on Russian archives and has been a major player in research on the RB-47 incident.

Through Adm Novvy’s efforts, documentation was located which stated that Eugene Posa’s remains were recovered by a Russian trawler crew a few months after the shootdown. Posa’s final burial location and information on the other two EWOs is still a matter of archival research.

Pat and Maria were especially taken by Adm Novvy’s genuine and helpful manner, and he encouraged the ladies to visit Russia. The Admiral helped facilitate arrangements for such a trip.

Fast forward to May of this year and here is an account from Pat Phillips:

After many months of preparation and much paperwork, we were finally on our way to Russia. On May 29, 2004. Maria Goforth McAtee, her daughter **Linda Schilder**, my daughter, **Roxann Phillips**, and I departed for St. Petersburg, Russia. We were very excited, and a bit anxious. How would we manage with the language and cultural barriers?

We had been invited by RAdm Boris Novvy, Russian Navy (Ret), who met us at the airport with flowers, hugs, and a big smile. We spent twelve days in St. Petersburg under his guidance. He had arranged an itinerary for us, and for a translator to be with us every day.

The Admiral and Kate (our translator) met us each morning at our hotel and off we went. We were escorted to many wonderful museums, including the Hermitage, and to churches, and palaces. Adm Novvy had arranged for a small bus to take our group to outlying areas of St. Petersburg.

We spent several days roaming the city, shopping, and boating on canals.

We enjoyed wonderful bright, sunny weather and we learned it didn't get dark until 2:00 AM and was bright again by 5:30 AM.

Our out-of-town visits included Novograd, a 13th century village with a working monastery. So very beautiful. Another day we traveled to Gatchina, a village where the naval archives are kept. We met the gentleman who heads the archives. He assured us that they were still searching for answers for us.

The palace in Gatchina is still under reconstruction of damage from WW II bombings. How proud they are of the treasures they have saved and the work they are doing.

Another day trip was to Pushkin where the summer palace of Catherine the Great is. It is also where Adm Novyy and Kate lived.

The next out-of-town venture was to Peterhof, the summer palace of Peter the Great, with its beautiful gardens and fountains. Adm Novyy treated us to an evening at the Marinski Theater where we saw three beautiful ballets.

We ate several wonderful Russian meals. Our translator did a super job ordering for us. The vodka that came with the meals was very potent!!

We learned so much and saw so much beauty, that it changed our thoughts of Russia, and especially the people. We found them to be very warm and welcoming.

One bit of irony, we were in St. Petersburg when President Reagan passed away. Everyone

offered us their sympathies for "your great president."

After twelve truly fantastic days we flew to Moscow arriving on June 12th, Russia's independence day. Red Square was a hub of festivities. Mr. Putin was speaking so security was tight. We did visit the Kremlin and toured the armory where many of the crown jewels are kept. We also saw Lubyanka Prison where John McKone and Bruce Olmstead spent several months.

We did get to attend the Bolshoi Ballet and saw "Sleeping Beauty". It was magnificent.

This was the trip of a lifetime! How fortunate for us, after all these years, to have such a wonderful experience. Wherever we went we were treated royally and with the utmost respect.

Our host and our translator wanted very much for us to leave with wonderful memories. Oh my goodness! What a few days and kind people can do for one's memory book.

Maria McAtee added these comments:

Initially, I had mixed feelings about Russia. Some expectations came from my misconceptions of who the people really were. I found them to be very friendly, religious and proud of their country. They appeared to be very family-oriented with both mothers and fathers spending time playing with their children in the parks.

The country itself is very majestic with beautiful buildings everywhere. Everything was kept spotless and well maintained even though the buildings are very old.

Russian food was delightful, especially the ice cream.

It's All About Information Operations Integration

Air Combat Command's (ACC) RC-135V/W Rivet Joint (RJ) has evolved over the past 14 years to become one of the most dynamic, operationally tasked airborne reconnaissance aircraft in the Department of Defense fleet. On any given sortie it's typically tasked to support an array of mission

areas, ranging from complex strikes to personnel recovery and beyond.

Today's modern battlespace often depicts a web of integrated assets, to include airborne, space based and complex ground nodes. These nodes help refine and focus right-time/right-place effects on an enemy. The RJ is well on its way to becoming the central airborne Information Operations (IO) node in support of warfighting operations. The RJ mission will soon become the main clearinghouse between traditional ground-based assets and real-time tactical systems. By cutting out the proverbial middleman, the RJ can fuse disparate sources of battlefield information to direct and enhance situational awareness to both kinetic and non-kinetic assets. Simply put, it's the tactical hub of National Tactical Integration.

The RJ generally achieves full horizontal integration through the use of advancing technology and the professional warriors conducting the mission. At any given time, there are literally hundreds of sensors on the battlefield with eyes and ears actively working 24/7, 365 days a year to nail down targets essential for Predictive Battlespace Awareness and Time Sensitive Targeting. The RJ's capability to bundle real-time multi-axis sensor data with persistent dwell time is the key to information superiority over an opponent. When we can disrupt, degrade and destroy an enemy inside its battle cycle, they can never win.

So how is this accomplished? It's done with Machine-To-Machine, known as M2M, technology. Through automation, computers solve complex intelligence and engagement solutions and provide decision makers with actionable information within seconds, vice minutes or even hours. One of the newest emerging M2M systems is known as Network Centric Collaborative Targeting. It's designed to employ geo-locational algorithms that tie both on- and off-board sensors/databases to pinpoint Time Sensitive Targeting actions in the Find, Fix, and Track phases of the F2T2EA—the "Find, Fix, Track, Target, Engage, Attack" kill chain.

Not only does the RJ bring traditional strategic partners to the battlefield through NTI, it also plays a significant role with other critical warfighting assets. These are typically referred to as the Command and Control, Intelligence, Surveillance,

and Reconnaissance, (C2ISR), platforms, such as the E-3 AWACS, E-8 JSTARS, EC-130H Compass Call, U-2, and various Unmanned Aerial Vehicles (UAVs), such as Predator and Global Hawk.

The RJ enhances war-fighting capabilities through a combined direct support campaign where cross-cueing and fusing of individual C2ISR feeds contribute to a larger picture. This includes active participation on both data and voice networks like Information Broadcast Service, Link-16, Improved Data Modem, Voice Product Net, and Satellite Communications (SATCOM). Effectively integrating and cross-cueing the RJ mission with other ISR platforms is a force multiplier providing correlated target information. In a typical cross-cue scenario, one platform provides a signals or imagery intelligence tip-off to the Combined Air Operations Center, which then tasks one or more systems to correlate the target and provide amplifying information. For example, if an RJ relays combat information used to identify weapon system types and potential threats to friendly forces, weapons employment decisions can be made based on the data.

One of the most recent technological innovations the RJ has seen involves direct connectivity to national intelligence producers. The system is referred to as Narrowband Reach Back (NABRE). The primary goal of the position, known as the Information Integration Officer or IIO, is to act as a real-time gateway between key intelligence nodes, both on and off the battlefield. The IIO's charter is to keep tactical platforms on the same sheet of ISR music with an assortment of other mission support functions, like the Distributive Common Ground System, Cryptologic Support Groups and space-based assets. This facilitates focused collection and reporting efforts to synchronize the entire ISR constellation with the theater commanders' battle rhythm. The ultimate aim is to provide a true simultaneous Time-Phase/Task-Apportionment ISR mission to support specific effects-based operations.

The RC-135 fleet has also participated in every sizable armed conflict involving U.S. assets. RC-135s were present supporting operations in Vietnam, the Mediterranean for Operation EL DORADO CANYON, Grenada for Operation URGENT FURY, Panama for Operation JUST

CAUSE, and Southwest Asia for Operations

I just wanted to add my two-bits to **John Draper's** comments regarding air rescue backup and those who may have flown on "both sides of the fence" (*Newsletter-June 2004*).

Prior to joining the 55th SRW at Forbes in 1964, I was a navigator in the 81st Air Rescue Squadron based in Sembach, Germany, in 1957-58. In addition to our primary SAR aircraft, the SA-16 Albatross, we also flew SC-47s. Almost nobody has ever heard of these aircraft. They were basically Gooney Birds that were airborne gas and oil tanks.

The primary mission was long range rescue and recovery. If I remember correctly, they could stay aloft for something like 43 hours. No in-flight refueling for us.

I didn't get to take the training at Stead AFB, NV, (maybe since I was already based in Germany).

The first contingent of aircraft left Stead flying non-stop for Sembach, with their primary alternates in Africa and the secondaries in England. That's a long way to bore holes in the sky at 120 knots IAS. Even then there were still hours of fuel remaining on board.

A typical training mission was 6-8 hours long.....takeoff, gear up, level off at 300 feet and stay there for the rest of the flight. To make it more interesting, we had to make a 15 to 30 degree heading change every 3 to 5 minutes. No radar, no inertial guidance, nothing but a windshield. That's right, the one and only nav on board stood between the pilots. It's a wonder any of us can stand up straight nowadays.

The aircraft were capable of landing in cow pastures, and if memory serves correctly, they had JATO capabilities. We were on-call, never knowing what our destination was, just that we just might be bringing some of our own home from someplace across the border to the northeast. The unit, to my knowledge, never flew an operational mission of that profile.

After getting into the 55th, it was comforting to know that a 'friendly' might come along if we were ever in need of a low and slow ride home. So, John, there are indeed some of us who, along with you, worked both sides of the fence.

I joined the 343rd SRS at Forbes in 1964 and flew RB-47s; transitioned to the RCs and went to Offutt; and then on to Eielson for five years before going to Southeast Asia in 1972.

B-47 BENCH DEDICATION

The B-47 Stratojet Association commissioned a commemorative granite bench to be placed at the nose of the B-47 bomber on display at the former SAC Museum near Ashland, NE. The dedication ceremony took place on 13 August 2004.

After a 30 minute reception and opening/welcoming remarks by Museum Director **Scott Hazelrigg**, B-47 Stratojet Association President (and a member of the 55th SRWA) **Dick Purdum** unveiled the bench. He stated, that the "bench is in memory of those who had anything to do with the B-47. This includes the Boeing engineers, crewmembers, crew chiefs, maintenance troops, cooks, security police and many others."

The top of the bench has a depiction of an RB-47H in the center, flanked by a B-47 and WB-47. Also shown are the American flag, SAC and MAC shields, the Stratojet Assn/Boeing B-47 logo, dedication words, and the phrase, "Peace is Still Our Profession".

About 30 people attended, including ten 55th SRW Association veterans who crewed Stratojets during the Cold War.

MILITARY RECORDS

The straight word from AF Retiree News Service:

The rumor circulating on the Internet, in e-mails and among veterans organizations that official military personnel files at the National Personnel Records Center (NPRC) will be digitized and then destroyed **is simply not true.**

Neither the Department of Defense nor the NPRC intend to destroy any official files stored at the Center, according to officials of the National Archives and Records Administration (NARA), the agency NPRC is under.

The purpose of **any** electronic scanning is to help **preserve** the originals and increase efficiency in handling reference requests.

NARA preserves and protects records that were transferred from the military service departments because they are permanently valuable records that document the essential evidence of military service for the veterans of our nation. NPRC stores and services official records for retired, discharged, or deceased military personnel.
